

## **SUMMARY ANNUAL REPORT FOR ALLSCRIPTS RETIREMENT SAVINGS PLAN**

This is a summary of the annual report for the ALLSCRIPTS RETIREMENT SAVINGS PLAN (Employer Identification Number 56-1306083, Plan Number 004) for the plan year 01/01/2020 through 12/31/2020. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

### **Basic Financial Statement**

Benefits under the plan are provided by insurance contracts and a trust fund. Plan expenses were \$119,725,593. These expenses included \$309,794 in administrative expenses and \$119,385,921 in benefits paid to participants and beneficiaries, \$29,878 in certain deemed and/or corrective distributions, and \$0 in other expenses. A total of 7789 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$934,460,089 as of the end of the plan year, compared to \$834,725,362 as of the beginning of the plan year. During the plan year the plan experienced a change in its net assets of \$99,734,727. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of \$219,460,320, including employer contributions of \$20,645,784, employee contributions of \$47,935,632, other contributions/other income of \$11,048,423, and earnings from investments of \$139,830,481.
